AIR COMMAND HEADQUARTERS SALARIES

Question No. 1,219—Mr. Howie:

What amount has been budgeted for salaries for the present year of operation of Air Command Headquarters at Winnipeg?

Hon. Barney Danson (Minister of National Defence): For fiscal year 1976/77: Military Personnel, \$5,720,000; Civilian personnel, 1,740,000; Total, \$7,460,000.

PMQ SURPLUS AT GAGETOWN

Ouestion No. 1.222-Mr. Howie:

Has the Department of National Defence identified one hundred PMQ units at CFB Gagetown as surplus to the Department's needs and have the units been offered for sale and, if so, to whom and for what amount?

Hon. Barney Danson (Minister of National Defence): The proposed changes to the land force posture make it necessary for DND to retain all the Gagetown PMQ units for the forseeable future. No units have been offered for sale.

- 1. Are any permanent civilian positions at CFB Gagetown being deleted from the plan or organization within the next year and, if so, how many?

Hon. Barney Danson (Minister of National Defence): 1. Yes. Two.

FOREIGN INVESTMENT REVIEW AGENCY

Question No. 1,231—Mr. Beatty:

- 1. For each month since the creation of the Foreign Investment Review Agency, how many cases have come before it for approval?
 - 2. How many applications have been (a) approved (b) refused?
- 3. What is the (a) shortest (b) longest (c) average (d) mean amount of time expressed in days, between the date of application and the date on which a decision was made?
- 4. Has the time limit for an offer to purchase ever expired prior to the FIRA making a decision on an application and, if so (a) in how many cases (b) in each case (i) what was the company involved (ii) how many days did it take to make a decision?

- 2. As of December 3, 1976, the Governor in Council had (a) allowed 345 applications; (b) refused to allow 53 applications. In addition, 65 applications had been withdrawn.
- 3. Between the date of certification of receipt of an application and the date of decision by the Governor in Council: (a) the shortest amount of time was eight days; (b) the longest amount of time was 484 days; (c) the average amount of time was 112 days; (d) See (c).
- 4. (a) To the best of the agency's knowledge, there have been at least six acquisition cases in which the offer to purchase expired before a decision was made by the Governor in Council. There may have been other cases as investors are not obliged to advise the agency of any time limits applicable to their investment proposals. Also, in a number of cases purchase agreements have been extended pending a decision under the act. (b) Ordinarily, in cases where a purchase agreement expires before a decision is taken by the Governor in Council and the agreement is not extended, the case is withdrawn and, consistent with the requirements of section 14 of the act, the names of the parties to the proposed acquisition are not made public by the government.
