Hon. James A. McGrath (St. John's East): Madam Speaker, the Prime Minister knows that statement is just not consistent with the facts because it was his government which insisted on having this matter brought before the Federal Court on the SIU case, and that is what set off the breakdown in negotiations. The Prime Minister knows that to be a fact.

Now, Madam Speaker, the government of Newfoundland, supported by the people of Newfoundland, has agreed to a reasonable compromise proposal which would call for joint management and revenue sharing. That is a reasonable proposition, and I ask the Prime Minister if he is prepared to be reasonable—

Mr. Lalonde: That is what we offered.

Mr. McGrath: —because we cannot expect any reason from his Minister of Energy, Mines and Resources. Is the Prime Minister prepared to be reasonable and say to the people of Newfoundland on the basis of that compromise proposal, which was accepted by the people of Newfoundland in a democratic election yesterday, that we are prepared to sit down and negotiate so that we can get on with the development of this resource not only for the people of Newfoundland, but for the people of Canada?

Some hon. Members: Hear, hear!

Right Hon. P. E. Trudeau (Prime Minister): Madam Speaker, I really cannot accept the interpretation which the hon. member put on the SIU case, as though we had started a reference to the court. It is quite clear that for a decade we tried to reach a negotiated settlement. In very recent times the matter went to the courts in two ways: first, the SIU took it to the courts and raised an issue of ownership where the governments were dragged, if I may say, into that issue; second, the government of Newfoundland made a direct reference to the Appeal Court of Newfoundland.

Mr. McGrath: You brought it in the back door.

Mr. Trudeau: So how can the hon. member say that my statement is not in accord with the facts?
