projecting the third allotted day in this supply period was changed following the decision of the Chair on Thursday last.

The other point I would like to deal with is the allegation of the hon. member that the notice filed in the name of the Right Hon. Leader of the Opposition should have been printed on Friday's notice paper, since Friday, February 12, had been designated as an allotted day. As hon. members are aware, the government House leader indicated that February 12 would not be an allotted day and that instead Friday, February 19, would be the third allotted day in this supply period.

I need not remind hon. members of the discussion that took place on Thursday on this particular matter when I indicated to the House that, in accordance with Standing Order 18(2), government orders are called and considered as the government determines. Consequently, Friday, February 12 not being an allotted day, the notice paper did not reflect the text of the right hon. member's motion, nor the text of another motion received from the hon. member for Humboldt-Lake Centre (Mr. Althouse).

In his argument, the hon. member for Yukon suggested that, since the notice had not been withdrawn, the text of the motion should have been printed on the notice paper. I am in full agreement with the hon. member that the text of both notices, despite the fact that one was dated and one was not, should have appeared on the notice paper under the appropriate heading and I have directed the Clerk of the House to see to it that they are indeed printed on tomorrow's notice paper.

ly visiting Mrs. Dougan's mother and brother in Orillia, be allowed to remain in Canada as landed immigrants on humanitarian grounds. They are concerned that if the Dougans are deported back to Northern Ireland, it will be under threat of certain death.

Tariff rates were not increased at Ottawa, Gander, Halifax, Toronto, Charlottetown and Mirabel airports.
