#### GOODS AND SERVICES TAX BROCHURE

**Mr. Nelson A. Riis (Kamloops):** Mr. Speaker, I rise on a related question. We found out this morning via the press that the Minister of Finance and the Department of Finance had sent out 1.8 million copies to small businesses across Canada. Members of Parliament have yet to receive copies in our offices.

Could the Minister of Finance explain when he had copies of this goods and services tax information booklet sent to the offices of members of Parliament? I wonder if he could explain when that was done.

**Mr. Wilson (Etobicoke Centre):** Mr. Speaker, these pamphlets have just gone out to small businesses. It was done through the Department of National Revenue. I am not quite sure precisely when they went out. If my hon. friend would like more copies of the document—

#### EXCISE TAX ACT
