





AND SHOT TO DEATH

Two Men Are Killed in Coun-

ty Louth by Men in

Uniforms.

The assassing are said to have worn uni-forms. Both O'Carroll and Tierney, who were between thirty and thirty-five years of age, were known to be in sympathy with the Sinn Fein cause, altho not promin-ently connected with that movement. O'Carroll was taken from his lodgings and conveyed toward the railway station, where he was shot with a revolver. His cries attracted the attention of persons in the neighborhood, who carried him in-to a house and summoned a doctor and priest. Death came shortly afterward. Tierney was removed only a few paces from his father's house and shot. He died instantly. The military court of inquiry into the deaths was private. The solicitor ropre-senting the men's kin was ejected be-cause he objected to a ruling of the presi-dent of the court as unconstitutional.
