HAWAII PREPARED TO WAIT. San Francisco, Feb. 25.—President Dole, of Hawaii, has received a copy of the message submitted by Acting President Cooper to the legislature, which met at Honolulu February 16. On the subject of annexation the message says: "Owing to the intimate relations existing between the republic and the United States of America, great care should be exercised that its action should be taken which shall interfere with the scope of the annexation treaty, nor in any way jeopardize the present friendly factory relations, nor hinder the future presentation of the treaty, should it fall to the lot of the senate of the United States, where it is now pending."
