

# LIPTON LTD. DROPPED FROM CONTRACTORS LIST

Won't be allowed to supply to British army in consequence of recent canteen scandal.

London, July 6.—Baron Lucas, as representative of the government, formally announced in the House of Lords today that Lipton's Limited had been removed from the list of contractors for the British army. This action was taken as a consequence of the recent scandal in connection with the army canteen contracts, for which several army officers and civilians employed by Lipton's Limited were convicted on charges of receiving and giving bribes.

# BRIDGE CONTRACTS ON I. C. R. AWARDED

Ottawa, July 6.—The government has awarded a number of contracts for substructures of several new bridges on the Intercolonial. The construction of these bridges is part of the government's policy for the general improvement of the physical condition of the railway. The contracts in New Brunswick are as follows:

W. R. Fawcett, Temperance Vale, N. B., District No. 2—Kouchibouguac river, \$7,182; Barnaby river, second crossing bridge, \$2,425; bridge half mile west, Sayabec, \$2,773; Black river bridge, \$1,699.

District No. 4.—French river bridge, \$6,448.

R. B. Stewart, Derby Junction, N. B., District No. 4—Barnaby river, 3rd crossing bridge, \$11,288.

# BACKS UP MINISTER OF JUSTICE FOR REFUSING CLEMENCY

Ottawa, July 6.—The Evening Journal says editorially today: "The refusal of the Minister of Justice to be influenced by the memorial asking clemency in the case of the Winnipeg bandit Krafchenko, who coolly murdered a bank manager at Plum Coulee some months ago, will be approved by right thinking citizens everywhere. Not to punish cold-blooded murder is to move a vote of censure on the police and organized society. There are too many applications for clemency now-a-days, anyway. Sloppy sentimentalists are to be found all over the country, who will place their signatures on petitions to save the lives of criminals, without considering a word of the evidence against them. The thing is getting to be notorious. One has only to give the slightest study to the criminal statistics of the civilized countries of the world to realize that capital punishment is in the interest of society at large. It is just as well to strongly emphasize the fact that 'gunmen' will not be permitted to thrive in the atmosphere of British law."

# MILITANTS BOMBARD THE KING AND QUEEN WITH LITERATURE

Edinburgh, July 6.—The suffragettes took advantage of the visit here today of King George and Queen Mary to prepare the usual suffragette demonstration, in which the bombardment of the royal couple with suffragette literature was the feature.

The women obtained possession of a balcony in a house opposite the station, and as the Royal carriage emerged they threw down upon it a lot of suffragette appeals. Then two detectives seized them, spilling their aim. Some of the handbills fluttered into the street, and the royal carriage passed over them.

The King, looking up, saw the women struggling in the arms of the officers. They were removed to the police station, the crowd along the way giving them a mixed reception of cheers mingled with hooting.

Among their missiles was a paper ball containing a message, "to show King George that women are being persecuted for defending their freedom."

# SAYS FOGHORN AT COVE ISLAND AGROUND

Fort William, Ont., July 6.—Captain Davies of the C. P. R. steamship Alberca, which arrived from Port McNicoll this morning, stated that the fog horn at the Cove Island light, off which the Assiniboia flagship of the C. P. R. did not sound until thirty-seven minutes after the Assiniboia had struck. He also stated that if the fog horn had been sounding during all the time when the fog was on the lake, the accident would not have happened.
