### General Intelligence.

**Alcohol as a Medicine.**

INTERESTING DISCUSSION BY THE DOCTORS AT THE RECENT MEETING OF THE MEDICAL SOCIETY OF N. B. AT ST. JOHN.

At the afternoon meeting of the Medical Society, Dr. T. W. Masgrove read a paper on "The proper use of alcohol as a medicine, and the responsibility of physicians in prescribing it." He pointed out the effects of intemperance, which, he asserted, were largely the result of improper administration of liquor by physicians. He thought the time had come when a proper system of administering the alcohol should be devised. Liquor, he believed, should be taken as opium or any other drug. Moderate drinking, he declared, was both unscientific and unchristian. He presented statistics to show the evil effects of the drug upon the human system.

Dr. S. Z. Earle, while agreeing with some of the speaker's remarks, cast a doubt upon the correctness of his statistics.

Dr. Moore was of the opinion that alcohol had been used in the past needlessly, and that every year the diseases in which it can be used are growing less and less numerous. He was considering it simply from a medical standpoint. In such diseases as diphtheria, low forms of typhus and cholera, he believed it was better adapted to a Division of the Sons of Temperance than to the Medical Society.

Dr. Earle did not think the resolution was in order.

Dr. Bayard thought the society should be a little cautious about passing such a resolution. It is an acknowledgment that a large number of medical men are in the habit of giving the drug to an unlimited extent.

Dr. D. E. Berryman thought the motion was an admirable one, but he felt that it was not the duty of physicians and to their patients to adopt it. He never read a letter from the W. C. T. U. He was of the opinion that the medical fraternity, the medical men were the strongest temperance workers in the community.

Dr. Gray stated that he failed to view the ladies' letter in the same light as Dr. Nevers. He would support the motion.

Dr. Nevers thought Dr. Masgrove's position was absolutely unassailable. The eminent practitioners of the day are the advocates of alcohol. He believed the motion was strictly in order.

Dr. Masgrove thought it would not be a mistake to believe that he had made mistakes. The spirit of the ladies' letter was in the right direction.

Dr. Barker said he was a firm believer in non-alcoholic medication. He has entirely discarded the use of alcohol, and gives instead tea and milk.

Dr. Covay, of Moncton, thought the prescription of any drug should not be given until the patient has been examined by a physician.

Dr. Steeves thought the resolution should not pass. We should be simply stultifying ourselves. It was not only undignified but unnecessary.

Dr. White agreed with the last speaker. He would oppose the motion.
