Crown Point, Ind., Jan. 21.—B. F. a Menace to the United States. The Detroit News has a double leaded special from Washington, in which its correspondent says: "Perhaps the most important of all the recent rumors of unrest and of possible further struggle, is one which comes exclusively to the News this morning.

From Buffalo great fleets of barges, heavily laden with coal, will shortly start across Lake Erie for Canadian ports, from which the cargoes of the vessels will be distributed along the for Canadian delivery from the Penn-

sylvania coal fields.
"At least one coal mining firm has evidence which leads it to believe that the purchases of coal have been made in behalf of agents of the British, or, at least, of the Dominion Government.

"Fuel has come to be as important an article in aquatic warfare as gun-powder. Accordingly the shipments of 1,000,000 tons of coal to be distributed along the Canadian districts bormuch hostile significance as similarly large and unusual shipments of explosive ammunition. It is to be inquired for what possible use can these great quantities of fuel bought, it is alleged, by Government agents, be destined, unless they have been purchased as a precautionary measure in view of possible international trouble in the future?"

In commenting on its correspondent's dispatch the News says:
"A Grand Trunk official says there would be nothing surprising about a coal order of three-quarters of a million tons for their own lines west of the tunnel. It requires several hundred thousand tons every year to supply the locomotives, and the order is usually placed about this time. O. W. Shipman, of Detroit, was announced some time ago as having a contract to furnish the Grand Trunk lines with 750,000 tons of Pennsylvania coal."


