BECHER MAY HAVE
ACTIVE COMMAND
London Recruit Says He Has
"Hunch" To That
Effect.
IS POPULAR WITH TROOPS
Men Chafing For Chance To
Avenge Raid on English
Towns.

A "hunch" that Lieut.-Col. Becher
will be in command of a division of the
first Canadian contingent; an intima-
tion that the Canadians are chafing for
a chance to avenge the German raid
on Whitby, Scarborough and Hartle-
pool, with a confidence that they can
more than even scores; the expectation
that the Canadian infantrymen would
very soon be on the battle line, are mes-
sages just received by Mrs. James Kin-
sella, of 129 Dundas avenue, from her
husband. The letter was dated Bus-
tard Camp, Salisbury Plain, on
Christmas Day, and gives an account
of how most of the troops which issued
from this city passed the glorious holi-
day. Mr. Kinseila, who is a member of
the recruiting corps, has been sending
signalling corps. He acknowledges the
receipt of a packet forwarded by his
wife, containing an abundance of tobacco,
cigars, cigarettes and other luxuries,
saying:

"One Towel in Three Weeks.
"Many thanks for your kind and most
useful present. You have sent the
things I required, most especially the
towels, for we have all been using one
towel for about three weeks, so when
your parcel arrived there was great re-
joicing, as we would look a little
cleaner. The cigars, too, were famous,
and we all in lieu of drinking your
health, smoked it.
"I have just come from the big mar-
quee, where we all gathered for din-
ner, and a right good spread it was.
The officers were waiting on us, and
after dinner there was speech-making
by some of them. In the absence of
Col. Hill, Col. Becher presided.
"He made a very nice little speech,
and referred feelingly to our friends,
relative and otherwise in Canada. I
have never seen a more popular com-
manding officer, and the troops were
waiting for a chance to show their
gratitude for him. They made old
Bustard camp ring to the echo.
Cheers for Col. Becher.
"He had to give up, for you could
hear nothing but only 'Three cheers
for Col. Becher.'"
"The next in popularity was Lieut.
Chester Butler. He came in for a
good roasting, but he thoroughly de-
served it. A nice gentleman I have
never met. He seems to be a great
favorite of everyone all through the
whole contingent.
"When we go to the front, which is
in a very short time from now, we all
hope that Col. Becher will be in com-
mand, and somehow I have a hunch
that he will be.

"The frost in the ground is pretty
deep for England. We are still under
canvas, I think it is the first time
that record for any troops to be under
canvass this time of the year in England.
Never mind, we are not downhearted.
"The Germans are mistaken if they
think that they can catch us asleep. We
are alert and ready for anything.
Hartlepool with its guns, which we
get over there. If we cannot beat them
we will give them such a mauling that
they shall never get over it.
"When I go to the front, I shall be
as I possibly can, and you must write
me the same. You know, our let-
ters will have to pass through a great
deal of paper. My mail and yours will
perhaps be limited.
"I have just seen George Cheatham
later. Will look him up one of these
fine days in the near future. Tell Mrs.
Cheatham that when I last saw her
she was looking well. I was glad to
hear her say 'Any news?' How are
they getting along?
"Fine" is my answer.
"That's good."

MOVE MANOR HOSPITAL
TO BULFORD VILLAGE
Mrs. A. H. Galbraith, 462 Princess
avenue, is in receipt of a letter from
her son, Lieut. Campbell Galbraith,
warrant officer at Bulford Camp Hos-
pital. Lieut. Galbraith states that
the hospital has been moved from Bul-
ford Manor to Bulford village.

early start, but even at midnight, things
are not in any too good a shape. Have

"UTILITIES" FAVOR
CLAUBITZ INQUIRY
Commission Is After a County
Court Judicial
Probe.
MITCHELL FIGHTS MOTION
Warm Argument Arises Over
Settling of Costs Which
Would Follow.

There will be a county court judicial
inquiry into the Claubitiz charges if
the public utilities commission has the
power to secure one.
At the 1915 inaugural meeting of the
commission, held Monday afternoon, a
motion, presented by Commissioner T.
W. McFarland, asking that the charges
made by the special committee of the
1914 city council to the city council of
last year be referred to the court judge
for investigation, and that the costs of
such an inquiry be borne by the com-
mission, was passed.

Mitchell Fights Motion.
Commissioner F. G. Mitchell fought
against the motion, and offered in
amendment one that the whole ques-
tion be referred to the court judge,
with the request that speedy action
be taken by that body. His amend-
ment was seconded by Mayor H. A.
Stevenson. Put to the vote the Com-
missioner McFarland recorded their
stand against it, and the original motion
was carried.

A Precedent to Act On.
"Seeing that the council took no ac-
tion at its meeting today in connection
with the Claubitiz question, I would
move that this board do so," said the
commissioner. "I have been told that
a county judge has handed down a
decision in the case of a county magis-
trate charged with being a German and
disqualifying a council, and that a coun-
cil, when it does not pay the salary
or appoint the man, it asks to be in-
vestigated, has no power to prefer
charges. This seems to me to be a
precedent upon which we must act."
"We must do something to clear the
air. There is a lot of feeling on the
question, and every second man I meet
on the street is under the impression
that the county judge has given me
advice on the question. I will therefore
move that the charges made by the
special committee to the council be re-
ferred to the county court judge of the
County of Middlesex for investi-
gation. I will also add that the com-
mission pay the charges of the investi-
gation."

"Commissioner Mitchell has taken an
active part in this question, and I
would ask that he second this motion,
and that the city solicitor be asked to
advise on the question. I will guaran-
tee that if the investigation finds out any-
thing derogatory to Mr. Claubitiz, either
the street or the subject of a servant of
this council, that he will be discharged
forthwith."

Back to Council.
Commissioner Mitchell declared that
he had the city solicitor's advice that
the question should go back to the
city council before the board attempted
to deal with it.
"Why should the board pay the ex-
penses of this inquiry?" he asked. "Mr.
Claubitiz is well able financially to pay
his own expenses."
In explanation, Commissioner Mc-
Farland declared that he believed Mr.
Claubitiz should pay his expenses, but
as the men under charges were ser-
vants of the city, the charges should be
paid by the commission.

Commissioner Mitchell declared that
the council should be the body to deal
with it first.
"City Solicitor Meredith informed me
that we had the right, under the
Municipal Act, for an investi-
gation. As the hydro department is
beyond the jurisdiction of the city coun-
cil, I approve of the motion, and be-
lieve it will bring the question to
a head at once."
"I think it is due not only to the
men involved, but to ourselves to have
the question settled, said the chair-
man. "If Mr. Claubitiz is a man for
the position, then he should be
dismissed. If it is found that he is,
then the men who laid the charges
should apologize."
"Why didn't you do that before?"
asked Commissioner Mitchell.
"Ought To Do Something."
"Because I never thought there was
anything in it. I believed that it was
engineered for election purposes, to be
quite frank. The people expressed an
opinion, and I think that we ought
to do something."
"Yes, now that the flag waving is
all over, let's get down to business,"
supplemented Commissioner McFarland.
"We are organized here, and we
want to get these men's services again,"
said the chairman.
"If we need them very
badly, we're not suffering now," re-
plied Commissioner Mitchell, as he sug-
gested that there was no hurry in the
question. "You didn't miss the general
manager very much when he took five
or six weeks off to go to Germany last
year. What's the use of trying to
rain on the parade?"
At this juncture, Mayor Stevenson
asked the intention of the board in
reference to the reappointment of Gen-
eral Manager Claubitiz.
"I don't think the people want him.
There is no question as to that," said
Commissioner Mitchell.
"The charges against Mr. Claubitiz
and Mr. Hunt are direct charges and
ought to be cleared up," rejoined the
chairman. "It is charged that Mr.
Claubitiz aided a German to escape from
the country. Great Britain declared
war on August 4. On August 5 a
proclamation was issued giving alien
enemies seven days to leave the coun-
try."
"What about the arrests made here
before that date?" inquired Commis-
sioner Mitchell.
"People Have Judged."
"Gen. Hodgins told me that the only
one was of a man who was suspected
of being pro-German, and he was later
released. As I said before, this thing
should be settled."

"Well, the people have judged the
case," said Commissioner Mitchell.
"Yes, but the people may have been
fooled. It has happened in the past,
and it may happen again in the
future," was the chairman's answer.
"There was no fooling about this,"
answered the commissioner.
"Then why are you afraid to let the
inquiry go?" asked Commissioner
McFarland, directing his attention to
Commissioner Mitchell.

"I'm not afraid of anything, but I
want the proper procedure," was the
warm retort. "What's the use of
carrying this resolution and then find-
ing out if we have the power of not?
At the closing moments of last year's
council, this board came to the council
and asked it to have the case sent to
the county judge. The whole question
ought to go back to the city council.
The council has the information on the
matter, what's the use of us trying
to start in the very beginning again
without any information at all."
When Commissioner Mitchell made the
declaration that there was no charge at
all against Assistant Manager A. O.
Hunt in connection with the departure
of Carl Becker, the German whose con-
nection with the officials of the depart-
ment started all the trouble, Chairman
Pocock declared that Mr. Hunt had
been the one who had hired and dis-
missed Becker, and that Claubitiz had
nothing to do with the case at all.
"Someone is trying to draw a herring
across the trail introducing Mr. Hunt
into the question," declared Commis-
sioner Mitchell.
After this discussion and the sug-
gestion of Mayor Stevenson that the
whole question be laid over for a week
or two the vote was taken that asks
for the judicial inquiry.

Pocock Again Chairman.
Commissioner Philip Pocock was
again elected chairman. He was nomi-
nated by Commissioner J. H. Chapman.
There was no opposition. Commissioner
Chapman, prior to nominating the
chairman, had declined the office of
chairman, having been proposed by
Commissioner Pocock.
Mayor Stevenson made the suggestion
which the provincial departments of the
commission be assigned to the various
members of the board in order that
they might give these special depart-
ments their extra consideration.
Commissioner Chapman opposed the
idea, saying that it would interfere with
the general management of the depart-
ment, and that the appointments were made
and that the appointments could be
done so without granting a certain
amount of power.
T. W. McFarland was created chair-
man of the Parks Commission, and
Messrs. William Wray and W.
W. Gammage served last year in the
places taken by Messrs. Moore and
Metherall.
F. G. Jewell and A. Scraton were
reappointed auditors for the year.
A communication from Hamilton, pro-
testing against the arbitrary way in
which the provincial commission had
ordered rate changes in that city with-
out consideration of local conditions
was filed.
Acting General Manager E. C.
Buchanan reported that the difference
had been adjusted since the letter was
received.
An amendment was made in the
changed commercial lighting rates as
ordered by the commission. The old
rate was for the first 30 hours, three
cents for the next 20 hours, and six
cents for the remainder. The new
rate was to be five cents, two cents
and six cents for the next 20 hours,
and six cents for the remainder. The
discount was reduced to five cents with
the same discount according to the amend-
ment made.
The commissioners made the very in-
teresting discovery that while penalized
by the new Workmen's Compensation
Act, in reference to any injuries that
might befall commission employees,
there is no provision for insuring these
men in the act. The commercial com-
panies, which formerly held the con-
tract for the liability insurance of the
men, have cancelled the rates and are
now asking five per cent where for-
merly only one and a half per cent was
paid.
It was decided to only insure those
men engaged in hazardous occupations
instead of all in hazardous occupations.
Arrangements have been made for
the commission to meet as usual this
Thursday of the month at 3:30.

sioner Mitchell.
After this discussion and the sug-
gestion of Mayor Stevenson that the
whole question be laid over for a week
or two the vote was taken that asks
for the judicial inquiry.

Pocock Again Chairman.
Commissioner Philip Pocock was
again elected chairman. He was nomi-
nated by Commissioner J. H. Chapman.
There was no opposition. Commissioner
Chapman, prior to nominating the
chairman, had declined the office of
chairman, having been proposed by
Commissioner Pocock.
Mayor Stevenson made the suggestion
which the provincial departments of the
commission be assigned to the various
members of the board in order that
they might give these special depart-
ments their extra consideration.
Commissioner Chapman opposed the
idea, saying that it would interfere with
the general management of the depart-
ment, and that the appointments were made
and that the appointments could be
done so without granting a certain
amount of power.

T. W. McFarland was created chair-
man of the Parks Commission, and
Messrs. William Wray and W.
W. Gammage served last year in the
places taken by Messrs. Moore and
Metherall.
F. G. Jewell and A. Scraton were
reappointed auditors for the year.
A communication from Hamilton, pro-
testing against the arbitrary way in
which the provincial commission had
ordered rate changes in that city with-
out consideration of local conditions
was filed.
Acting General Manager E. C.
Buchanan reported that the difference
had been adjusted since the letter was
received.

Lighting Rates Amendment.
An amendment was made in the
changed commercial lighting rates as
ordered by the commission. The old
rate was for the first 30 hours, three
cents for the next 20 hours, and six
cents for the remainder. The new
rate was to be five cents, two cents
and six cents for the next 20 hours,
and six cents for the remainder. The
discount was reduced to five cents with
the same discount according to the amend-
ment made.
The commissioners made the very in-
teresting discovery that while penalized
by the new Workmen's Compensation
Act, in reference to any injuries that
might befall commission employees,
there is no provision for insuring these
men in the act. The commercial com-
panies, which formerly held the con-
tract for the liability insurance of the
men, have cancelled the rates and are
now asking five per cent where for-
merly only one and a half per cent was
paid.

It was decided to only insure those
men engaged in hazardous occupations
instead of all in hazardous occupations.
Arrangements have been made for
the commission to meet as usual this
Thursday of the month at 3:30.

TO CALL INDUSTRIAL
SCHOOL "TECHNICAL"
Idea of E. R. Dennis, Pointing
Out Need of New
Building.

There was a full attendance last
night at the inaugural meeting of the
advisory industrial committee of the
board of education, held in the Indus-
trial School, when an important item
of business was the appointment of
a chairman, E. R. Dennis being the
popular choice.
In his inaugural address, Mr. Den-
nis emphasized the great need of a
new building to give more scope for
the rapid development of vocational
training in this city. While \$250,000
has been spent on the Collegiate and
public school buildings in the past
few years, no sum has been set apart
for the extension of the industrial
work. As an evidence of its growth,
the first term, 100 certificates were
issued to 158 students, in the past
