The application for Assurance during the year to 30th April, 1909, was \$5,660,000, upon 2,401 lives, of which 154 for \$227,000 were not such as the Directors thought it in the interest of the Company to accept.

The total Assurances and Profit Premiums in force at 30th April last were \$46,848,870 upon 177,692 lives, and 23,286 policies.

The year's income has amounted to \$1,800,000, and the expenditure to \$987,401.41, the difference of \$812,598.59 was added to the Company's funds which were at 30th April last \$9,084,450.13.
