BILINGUALISM AND BICULTURALISM

FINAL REPORT OF COMMISSION—REQUEST FOR UNANI-MOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Roch La Salle (Joliette): Under Standing Order 43, Mr. Speaker, I request the unanimous consent of the House to move a motion concerning a question of vital importance.

It has to do with an announcement by the Royal Commission on Bilingualism and Biculturalism which, after consideration of subjects dealing with the Supreme Court, Parliament, arts and culture, mass media and political equality, has decided not to make any report on those subjects, report which was to be submitted to the Secretary of State and, through him, to the House. That decision of the Commission is contrary to the instructions of the Governor in Council as formulated in the terms of reference of the Commission as well as to those of the House which has voted the required credits enabling the Commission to carry on its inquiry—

Mr. Speaker: Order. Again, I must object to the way the motion is moved by the hon. member. Yesterday I took the liberty of mentioning to the hon. members for Sainte-Marie (Mr. Valade) and for Athabaska (Mr. Yewchuk), I believe, who were moving a motion under Standing Order 43, that they should limit their remarks to a brief indication of the urgency of the matter.

Under this order, the hon. member cannot express views on the substance of the matter for which he seeks consideration by the House. I therefore invite him to abide not only by the letter but also by the spirit of Standing Order 43.

Mr. La Salle: I was about to finish, Mr. Speaker. In view of the urgency of the matter, I ask the House to agree unanimously to the following motion:

That the Standing Committee on Miscellaneous Estimates be requested to inquire into the refusal of the Commission on Bilingualism and Biculturalism to print and publish its final report, and to report to the House on or before May 31, 1971.

Mr. Speaker: The House has heard the motion presented by the hon. member for Joliette (Mr. La Salle) pursuant to Standing Order 43. A motion of this kind requires
