examine the feasibility of the Queen's University study. However, the hon. gentleman will recall that that was with respect to the Mackenzie valley rather than the Yukon.

OIL—POSSIBLE SHARING OF RESOURCES BY OECD COUNTRIES IN EVENT OF MIDDLE EAST CUT-OFF— CANADIAN PARTICIPATION—BILATERAL APPROACH

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): Mr. Speaker, may I ask the minister a question in reference to his statement that the OECD members propose to have some sharing of their oil resources in the event of a Middle East oil cut-off. What surplus of oil does Canada have to contribute to such a plan, have any commitments been made, and is the minister making any approaches to Venezuela or any of the OPEC countries regarding a bilateral agreement to assure security of supply in the event of Middle Eastern oil being cut off?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, the OECD discussion is with regard to offshore supplies of oil coming to Canada, the United States, western Europe, Japan and Australia. For that reason it is not so much a question of Canada contributing to it but of the way in which offshore supplies would be dealt with. With respect to the bilateral approach suggested by the hon. gentleman, he will recall that Dr. Howland advised the standing committee that one of the aspects of the OECD agreement is that there should not be in effect competitive bilateral deals between various members of the OECD and the OPEC countries because of the competitive element that this would bring about.

TRANSPORT OF OIL FROM NORTH—CANADIAN NATIONAL RAILWAYS STUDY

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I should like to ask the Minister of Transport whether he would inquire about the studies carried out by the Canadian National Railway in respect of railway construction in the far north, and if they will be made available to committees of the House?

POLICE AND SECURITY PLANNING AND ANALYSIS GROUP—INQUIRY AS TO USE OF ELECTRONIC EQUIPMENT TO MONITOR CONVERSATIONS
