OFFSHORE VESSELS OPERATING IN GULF OF ST. LAWRENCE—  
MOTION UNDER S.O. 43

Since the large offshore fishing boats based outside the Gulf of St. Lawrence have recorded increased landings in the last two years, and whereas the small inshore fishing vessels based in the Gulf of St. Lawrence have not yet attained their full catch rate and are subject to a shorter fishing season, I move, seconded by the hon. member for Gaspé (Mr. Cyr):

That this House directs the Minister of Fisheries and Oceans to rescind, before the starting date of November 1, his decision to allow the return of non-Gulf based fishing vessels to compete with small inshore fishermen.

REQUEST GOVERNMENT DISALLOW FURTHER INCREASES IN  
INTEREST RATES—MOTION UNDER S.O. 43

**Hon. Marcel Lessard (Lac-Saint-Jean):** Mr. Speaker, I rise under the provisions of Standing Order 43 and ask for the unanimous consent of the House to move a motion on a matter of urgent necessity.

In view of the crisis that successive increases in interest rates have recently created in Canada; given the negative impact

That this government refuse for the time being any new increase in interest rates and introduce compensatory measures such as tax exemption adjustment, now set at \$1,000, on income originating from interest or dividends.

CALL FOR GUIDELINES TO ESTABLISH AIR QUALITY LAWS—  
MOTION UNDER S.O. 43

In view of the present efforts of the Pittston Oil Company, of New York, to locate an oil refinery in Maine which would produce unacceptable and intolerable levels of air pollutants in New Brunswick, and in line with the statement made in the House on October 22 by the Postmaster General and Minister of the Environment (Mr. Fraser) that both the United States and Canada "were polluting each other and effective control could best be undertaken on a co-operative basis", I move, seconded by the hon. member for Saint John (Mr. Ferguson):

That this House request the minister to consider a study which would establish guidelines for enforceable air quality laws and federal emissions requirements, complementary to those administered by the United States Environmental Protection Agency, which Canada does not have.
