### PETITIONS

#### AMNESTY FOR PRISONERS OF CONSCIENCE

**Hon. Ray Hnatyshyn (Saskatoon West):** Mr. Speaker, I have the honour to present a petition on behalf of approximately 1,800 Saskatchewan residents under the auspices of Amnesty International who call for a universal amnesty for all prisoners of conscience. They feel that such an amnesty, backed by the United Nations and declared by all governments, is indeed possible. If enacted, indeed it would be an unparalleled act in the building of international confidence and the promotion of fundamental freedoms.

**Mr. Bob Ogle (Saskatoon East):** Mr. Speaker, I also have the honour to present a petition from Amnesty International of almost 1,800 names of people who live in the City of Saskatoon, in the Province of Saskatchewan and in other provinces of Canada. The petition humbly sheweth that thousands of men and women are imprisoned throughout the world solely because of their political and religious beliefs, that others are held because of their colour or ethnic origin, that these are prisoners of conscience and none have used or advocated violence, that none of these people should be imprisoned, that the fact they have been arrested and punished because of their beliefs or origins is an affront to humanity, and that they should be freed unconditionally.

Wherefore the undersigned, your petitioners, humbly pray and call upon the Parliament of Canada to support and call for universal amnesty for all prisoners of conscience. And as in duty bound your petitioners will ever pray.

### PARITY PRICES FOR FARM PRODUCTS ACT

#### MEASURE TO ESTABLISH

**Mr. Lorne Nystrom (Yorkton-Melville)** moved for leave to introduce Bill C-232, an Act respecting Parity Prices for Farm Products.

He said: Mr. Speaker, I want to introduce a Bill entitled: "An Act Respecting Parity Prices for Farm Products" which contains a very short explanatory note as follows:

The purpose of this Bill is to provide parity prices to farmers based on a cost-of-production formula for wheat, oats and barley for human consumption within Canada and to establish voluntary marketing Commissions for pork and beef. This is to lay the groundwork for parity prices for producers.

Motion agreed to, Bill read the first time and ordered to be printed.
