- 2. Did the Bureau investigate each reported accident and, if not how many were investigated?
- 3. Did the Bureau initiate criminal prosecutions as a result of the investigations and, if so, how many?

- (c) (i) and (ii) The classification system for reported accidents includes those that actually resulted in death or physical injury and those that have the potential to do so. The system addresses actual and potential accidents equally but does not differentiate between the two.
- 2. Every reported accident is investigated but the depth and completeness of each investigation depends upon the severity of the hazard and the assigned priority.
- 3. Criminal prosecution constitutes only one of a range of possible remedial and corrective measures available to the Bureau. Over the six-year period in question the Bureau has implemented all of the following measures, except criminal prosecution:

- 2. HPB Information Letters
- 3. Safety Guidelines
- 4 Standards
- 5. Individual letters
- 6. Scientific publications

- C. Directives or recommendations for labelling improvements.
- D. Regulatory and compliance measures including:
 - 1. stop sale by manufacturer
 - 2. recall or corrective action
 - 3. seizure of stock
 - 4. refused entry to Canada
 - 5. criminal prosecution

Manufacturers

To transfer technological know-how developed by the Bureau, to suggest new methodologies, to advise on compliance with the Act and regulations, etc.

Users

To make users aware of hazards, to correct misunderstandings, to provide education and training to prevent misuse and human error.

Manufacturers, when the Bureau considers the hazard or ineffectiveness to arise from design errors or improper manufacturing.

Manufacturers, where the directions for use or other labelling are considered inadequate.

Manufacturers, when a serious and present hazard is discovered, or cooperation is not forthcoming, or the device is fraudulent, etc.
