EMPLOYMENT IN METRO TORONTO

Question No. 134-Mr. Heap:

In planning for labour market needs, has the government made predictions as to employment in Metro Toronto and, if so, according to these predictions (a) what will the absolute number of manufacturing jobs be there in (i) 1994 (ii) 1999 (b) what percentage will that be of the current level (c) which ten manufacturing subsectors will experience the greatest net job loss over the above time–frames (d) what size will that loss be (e) what is the predicted employment level in the clothing industry for the above time–frames (f) what job categories, overall, are expected to have the greatest absolute increase through 1994 and 1999 (g) in each case, what is their average expected pay level?

Hon. Barbara Jean McDougall (Minister of Employment and Immigration): Employment and Immigration Canada has not produced any official projections relating to the industrial and occupational configuration of the Metro Toronto labour market to the year 1999. The technical difficulties, the most serious being the lack of reliable data, involved in such an exercise are many. Until these constraints can be overcome, small area projections, rather than providing a useful planning tool, may in fact give an unrealistic picture of the future Metro labour market.

"GREENPRINT FOR CANADA: A FEDERAL AGENDA FOR THE ENVIRONMENT"

Ouestion No. 154-Mr. Caccia:

Is it the intention of the government to make an official response to "Greenprint for Canada: A Federal Agenda for the Environment", given to the Prime Minister on June 22, 1989 by the Greenprint for Canada Committee and, if so (a) by whom will the response be prepared (b) by what time and, if not, for what reasons?

Hon. Lucien Bouchard (Minister of the Environment):
a) Environment Canada Officials are presently preparing

a response to the *Greenprint for Canada: A Federal Agenda for the Environment*. This document has been Central in establishing a proposed framework for the Environmental Agenda for Canada.

b) Environment Canada hopes that representatives of the Greenprint Coalition group will be able to meet with departmental representatives in a Pre-Agenda discussion before the end of this year.

MR. FRANCISCO NOTA MOISES

Ouestion No. 155-Ms. Hunter:

Is it the intention of the government to conduct an investigation into the refugee status of Mr. Francisco Nota Moises and into the possibility of violations of the *Immigration Act* by him and, if so (a) on what date will the investigation commence (b) what are its terms and mandate (c) is the Department of External Affairs or the Canadian Security Intelligence Service to be involved in the investigation and, if so, in what way?

Hon. Barbara Jean McDougall (Minister of Employment and Immigration): A careful and thorough investigation has been conducted regarding Mr. Moises who was granted refugee status. This investigation was conducted in conjunction with the Department of External Affairs and the Canadian Security Intelligence Service (CSIS). No evidence was established to conclude that Mr. Moises' admission to Canada was irregular or that he could now be removed from Canada under the Immigration Act.

INVESTIGATION OF ALLEGED INFRACTIONS OF THE PARLIAMENT OF CANADA ACT

Question No. 170-Mr. Murphy:

Is it the policy of the government to investigate alleged infractions of the Parliament of Canada Act by (a) Members of the House of Commons (b) Senators?

Hon. Pierre Blais (Solicitor General of Canada and Minister of State (Agriculture)): The policy of the Royal Canadian Mounted Police (RCMP) is to investigate offences against any Federal Statute where a complaint has been received and there is sufficient grounds to believe that an offence may have been committed.

Should the RCMP receive a complaint relative to an infraction of the Parliament of Canada Act and the complainant provides sufficient evidence that an offence may have been committed then the matter would be duly investigated.
