

Mr. Rinfret, a Member of the King's Privy Council, then laid before the House, by command of His Excellency the Governor General,—Twenty-ninth Annual Report of the Civil Service Commission of Canada, for the year 1937.

Mr. Mackenzie (Vancouver Centre), a Member of the King's Privy Council, laid before the House,—Copy of Regulations for the Royal Canadian Navy, dated June 1, 1938, under the provisions of Section 44, Chapter 139, R.S.C. 1927.

Also,—Copies of General Orders and Regulations promulgated to the Canadian Militia and the Royal Canadian Air Force, dated June 1, 1938, under the provisions of Section 141, Chapter 132, and Section 4 (4), Chapter 3, R.S.C. 1927.

He also presented,—Partial Return to an Order of the House of February 14, 1938, for a copy of all contracts made by or for the Department of National Defence from the beginning of the present fiscal year (April 1, 1937) to date, as well as a copy of all tenders with respect to each such contracts.

A Message was received from the Senate informing this House that the Senate had passed the Bill No. 31, An Act to establish a Board of Transport Commissioners for Canada, with authority in respect of transport by railways, ships and aircraft, with amendments, which are as follows:—

1. Page 1, line 23. After "feeds" insert "in bulk or".
2. Page 2, line 2. After "bales," insert "waste paper loaded as full ship's cargo."
3. Page 2, line 8. Insert the following as new paragraph (g):—
 "(g) "harbour toll" means and includes every rate, toll and charge established or proposed to be established by any Act of Parliament or by, or with the approval of the Governor in Council in respect of ships or aircraft entering, using or leaving any harbour in Canada, or the passengers thereof, or goods loaded, unloaded, shipped, transhipped, moved in transit or stored in any harbour in Canada, or on or in any wharf, dock, pier, warehouse or other facility within the limits of any such harbour or situate on lands appurtenant thereto;"
4. Reletter present paragraphs (g), (h), (i) (j), and (k) of Clause 2 as paragraphs (h), (i), (j), (k), and (l).
5. Page 2, line 18. Insert the following as new paragraph (m):—
 "(m) "ship" when used in Part VI of this Act includes any ship, boat, barge, dredge, floating elevator, scow or any other floating craft and any raft, crib, dram or bag boom of logs, timber or lumber of any kind, and logs, timber or lumber in boom or being towed;"
6. Reletter present paragraphs (l), (m), (n), (o), and (p) as paragraphs (n), (o), (p), (q), and (r).
7. Page 3, line 18. Insert the following as new subclause (2) of Clause 3:—
 "(2) It shall be the duty of the Board to perform the functions vested in the Board by this Act and by the *Railway Act* with the object of co-ordinating and harmonizing the operations of all carriers engaged in transport by railways, ships and aircraft and the Board shall give to this Act and to the *Railway Act* such fair interpretation as will best attain the object aforesaid."
8. Page 4, line 15. After "that" insert "at any time".
9. Page 4, line 23. After "transport," insert "whether in bulk or otherwise,".
