**ENVIRONMENTAL AFFAIRS****SPRUCE BUDWORM—USE OF PESTICIDE SPRAYS IN FRASER CANYON AREA—APPROVAL FOR USE OF ORTHENE**

**Mr. Alex Patterson (Fraser Valley East):** Mr. Speaker, in the absence of the Minister of the Environment, may I direct my question to the acting minister or the parliamentary secretary? In view of the urgency of the matter and since federal officials have been engaged in discussing this question, could the acting minister advise whether a final decision has been made regarding the use of pesticide sprays in the control of the serious budworm infestation in the forests of the Fraser Canyon area of British Columbia?

**Mr. Jim Fleming (Parliamentary Secretary to Minister of Fisheries and the Environment):** No, Mr. Speaker, I understand that a final decision has not been made, although the government of British Columbia is expected to make such a decision this week. The view of the federal Department of Fisheries and the Environment is that, if it is properly handled, there are no serious dangers connected with the use of the pesticide needed to fight the spruce budworm.

**Mr. Patterson:** A supplementary question, Mr. Speaker. In view of the wide divergence of opinion on that particular question, can the parliamentary secretary advise whether, as has been alleged by some, the pesticide Orthene is still in the experimental stage, or has it been fully tested and approved for use in such circumstances?

**Mr. Fleming:** Mr. Speaker, Orthene has undergone extensive tests, as is necessary before its approval for use.
