London, July 1.—(By mail from the British representative of Canadian Associated Press).—"The promotion of trade relations between this country and Canada," said Charles F. Higham, M. P., to a press representative, "is regarded by all sensible city men, not merely as a matter of mutual interest, but also as an honorable obligation. Can we ever forget the dominion's noble sacrifices in the war, or her courage and determination in some of the fiercest of its battles? "I see by recent records that of the 418,000 men in the Canadian expeditionary forces, some 57,000 lost their lives and nearly 150,000 were wounded. They fought with a gallantry surpassed by no troops in the world. On the first day of the second battle of Amiens they made an advance of no less than 14,000 yards—the deepest advance, I am told, on any one day during the war. Their progress altogether in this battle was about fifteen miles. "We shall never forget their part in the final victorious drive. It was they who broke the Quent-Drocourt section of the Hindenburg line; it was they who encountered the bitterest struggle of the war, that which culminated in the capture of Cambrai; it was they who occupied Mons a few hours before the armistice came into effect. "Canadian in short, in the majority of British minds, is today synonymous with 'gallant.' No fewer than fifty-three Victoria Crosses fell to the men from Mapleland, besides about 15,000 other decorations. "Mr. Higham, practical business man as he is, does not think sound commercial relations can long subsist on sentiment alone, however lofty it may be. "The keen edge of self-interest—which, in this case, is the commercial equivalent of the law of self-preservation—will ruthlessly cut through the tenderest of ties.
