It shall be the duty of the said council, as soon as may be Council to after the passing of this Act, to frame such by-laws, rules and frame by-regulations, as shall seem to the said council best adapted to pro-laws, mote the welfare of the said corporation and the purposes of this Act, and to submit the same for adoption at a general meeting of

All subscriptions of members due to the said corporation, Recovery of under any by-law, all penalties incurred under any by-law, by subscriptions, any person bound thereby, and all other sums of money due to the 15 said corporation, shall be paid to the Secretary theseof, and in default of payment, may be recovered in any action brought in the name of the said corporation, and it shall only be necessary in such action to allege that such person is indebted to the said corporation in the sum of money, the amount of such arrearage, on

20 account of such subscription, penalty or otherwise, whereby an action hath accrued to the said corporation by virtue of this Act.

16. On the trial or hearing of any such action, it shall be Proof in such sufficient for the said corporation to prove that the defendant case. at the time of making-such demand, was or had been a member 25 of the said corporation, and that the amount claimed by such subscription, penalty, or otherwise, was standing unpaid upon the 'books of the said corporation.

17. The meetings of the members of the council shall be open Meetings of to all members of the said corporation who may attend at the Council to be open.
30 same, but who shall take no part in any proceedings thereat; and minutes of the proceedings at all meetings, whether of the said council or the said corporation, shall be entered in books to be kept for that purpose by the Secretary of the said corporation; and the entry thereof shall be signed by the president of thereof.

45 award in any commercial case or difference which shall be voluntarily referred to them by the parties concerned; and whenever any such parties shall agree to bind themselves, by bond or other-Powers wise, to submit the matter in dispute between them to the decision of the said board of arbitrators, such submission shall be understood
