The circumstances were entirely different in East Middlesex. Dr.Routledge, five weeks before the election, absolutely put a stop to his lifelong practice of treating friends. He was legally not a candidate until the Legislature expired by effluxion of time, which was about the end of March or early in April. He was not aware at first that the custom might be construed as illegal, but when so informed he promptly dropped it. Philadelphia, March 21.-Five men of the crew of the tug Pilot of this city, were drowned in a collision between the tug and the steamship Winigrid in the Delaware River off Marcus Hoo, Pa., late last night. The remaining three nembers of the crew were saved. The following were drowned: Alonzo Hazard, engineer; John Ben-

nett, mate; Frank Atkinson, steward; Albert Painter, deck hand; Portuguese fireman, name unknown. The Winirid was towing the barge Conemaugh from Port Arthur, Texas, to this city, and became fog bound in the Delaware Bay on Thursday. The tug Pilot had towed the Conemaugh and guided the Winifrid from the anchorage and was pulling in the hawser when the steamer crashed into her amidship. The tug soon sank. The Winifrid was unin-
