1. Last day for Railway Companies to transmit to Clerk of Municipalities statements of Railway Property. Assessment Act, Sec. 26. Last day for Collectors to return their Rolls and pay over proceeds. Assessment Act, Sec. 132.

Last day for County Treasurer to furnish Clerks of Local Municipalities with list of Lands in arrears for Taxes for three years. Assessment Act, Sec. 140.

- First meeting of Board of Education at 7 p. m., or such other hour as may have been fixed by resolution of former Board at the usual place of meeting of such Board. Public Schools Act, Sec. 106; High Schools Act, Sec. 13.
- The Legislative Assembly of the Province of Ontario meets at Toronto.
- Last day for Assessors to begin to make their Rolls. Assessment Act, Sec. 49.
- The House of Commons meets at Ottawa.
- Last days for Councils to pass By-Laws limiting number of Tavern Licenses to be issued for the ensuing year, or for imposing a larger duty for tavern or shop licenses. Liquor License Act, Sec. 29 a

Last day for City and Town Council to pass By-laws to prescribe further requirements as to accomodation in taverns. Liquor License Act, Section 42.
