and for the purposes of this section, a transaction between an importer that is a corporation directly 5 or indirectly controlled by the exporter and another person carrying on business or other activities outside Canada may be deemed a transaction between such person and the exporter, and any amount payable to the importer under or in respect of the transaction 10 may be deemed as being payable to the exporter;"
