RAILWAY BRANCH LINES-CONSIDERATION OF SUGGESTIONS OF PROVINCES

Mr. E. Nasserden (Rosthern): I should like to ask the Prime Minister what action is being taken to meet the suggestions of the provinces and other interested parties with ment recently by Premier Khrushchev with

regard to railway abandonment in Canada and the recommendations of the MacPherson commission report.

Right Hon. J. G. Diefenbaker (Prime Minister): The premiers of the three western provinces asked for a meeting with the government of Canada for the purpose of placing before the government their views on the abandonment of railway facilities in western Canada. We received a message on the 10th of this month. On the 11th we advised that at that time we did not think a meeting would be beneficial. Since then a bill has been completed in its draft form. It will not be introduced until these provincial governments have an opportunity of presenting their views. An indication has been given that we are prepared to meet with the premiers of Manitoba, Saskatchewan and Alberta on January 28.

SUGGESTED ROYAL COMMISSION TO STUDY CANADIAN CULTURAL SITUATION

On the orders of the day:

Hon. Lionel Chevrier (Laurier): May I direct a question to the Prime Minister and ask him if the government has taken a decision with reference to the inquiry on bilingualism and biculturalism, as proposed in this house by my hon, friend the Leader of the Opposition.
