## Inquiries of the Ministry DEFENCE PRODUCTION H.M.C.S. "BONAVENTURE"—ALLEGATION REGARDING OVERCHARGES IN REFITTING

**Mr. Erik Nielsen (Yukon):** Mr. Speaker, this question is directed to the Minister of Justice. On Monday last in answering a question put by the hon. member for Calgary North he indicated that informations had been laid against Remus Rodaru and Cardinal Engineering and Machinery Company Limited in connection with the Bonaventure bills. He also left the house with the impression that proceedings might be reinstituted. Can the minister affirm whether it is now possible to reinstitute those criminal proceedings that were terminated, as he explained on Monday?

Hon. John N. Turner (Minister of Justice): I said that the crown prosecutor here in Ottawa representing the provincial Attorney General had been unable to obtain the evidence of Erhardt Junkers in Germany and felt he had insufficient evidence to proceed, and the Crown applied to withdraw the charges. The magistrate refused the application and the preliminary inquiry was commenced. The Crown offered no evidence in the circumstances and the charge was dismissed.

In the circumstances described there was of course no trial. The hon. member is asking me for an opinion. It would appear that the defences of res judicata or autrefois acquit are not available. I think that is as far as I would like to go in an answer. It would be my view that if new evidence were furnished there would not be a bar to new proceedings.

### **VETERANS AFFAIRS**

REQUEST THAT ALLOWANCE NOT BE REDUCED BECAUSE OF INCREASED OLD AGE BENEFIT

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, I should like to direct a question to the Minister of Veterans Affairs.
