TELESAT CANADA—FINANCIAL PARTICIPATION OF COMMUNICATION COMMON CARRIERS

Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council): Mr. Speaker, on behalf of the Minister of Communications I wish to report the following: The correspondence requested relates to matters of a commercial character concerning negotiation between private companies and Telesat Canada, an independent corporation, and it would accordingly not be appropriate or in the public interest to publish it. I would, therefore, hope that the hon. member would consent to withdraw this motion.

Mr. Knowles (Winnipeg North Centre): I would rather that you put it to a vote, Mr. Speaker.

Some hon. Members: Question!

Mr. Speaker: Is it the wish that the matter be transferred for debate?

Mr. Knowles (Winnipeg North Centre): No, Mr. Speaker. I ask that it be put to a vote.
