COMMENDATION OF TORONTO POLICE ON SUCCESSFULLY DEALING WITH HOSTAGE-TAKING INCIDENT—MOTION UNDER S.O. 43

Mr. Perrin Beatty (Wellington-Grey-Dufferin-Waterloo): Mr. Speaker, I rise under the terms of Standing Order 43 to seek the unanimous consent of the House to move a motion about an important public matter. As members of the House will be aware, last night in Toronto at about 11.30 p.m. a hostage-taking incident involving 13 hostages came to an end peacefully. The successful conclusion of this incident, which ended without any injury, gave yet another example of the courageous and dedicated service given all Canadians by the police forces of this country.

**Mr. Beatty:** I would ask the unanimous consent of the House to move, seconded by the hon. member for Provencher (Mr. Epp):

That this House commends the members of the metropolitan Toronto police force for their courage and efficiency in bringing the hostage-taking incident of March 21, 1977 to a peaceful conclusion and it recognizes with appreciation the daily contribution of the police forces from across Canada whose bravery and dedication help to preserve the lives and safety of all Canadians.

Some hon. Members: Hear, hear!

Mr. Speaker: Order, please. I have some reservations about the urgent and pressing necessity of using the Standing Order in this way to extend these kinds of congratulations. It puts a very invidious choice upon the House as to whether such a motion should be debated or passed without debate. Nevertheless, under the circumstances I will put the motion. The unanimous consent of the House is required for the presentation of such a motion. Is there unanimous consent?

#### **UNEMPLOYMENT INSURANCE**

SUGGESTED MAINTENANCE OF CRITERIA TO QUALIFY FOR BENEFITS—MOTION UNDER S.O. 43
