COMMERCIAL FISHING REGULATIONS ON WEST COAST— MOTION UNDER S.O. 43

Mr. Ted Miller (Nanaimo-Alberni): Madam Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. On Wednesday the B.C. Salmon fishing season will open without the proclamation of proposed regulations concerning two-area trolling. The government's hesitancy in legitimizing its policy proposals and press announcements is a result of fisheries department confusion and uncertainty and a sign that political rather than conservation considerations are foremost in the minds of ministry decision-makers. I move, seconded by the hon. member for New Westminster-Coquitlam (Miss Jewett):

That the department curtail all major changes in commercial fishing regulations until the Pearse commission of inquiry has had the opportunity to hear the B.C. fishing industry's concerns and proposals and has reported back to the government and consultations with fishermen have followed so that a comprehensive management plan can replace the present ad hoc policy formation which is destroying the opportunity to make a living in the B.C. fishing industry.
