In applying the provisions of the Pension Act most awards are effective from the date of application. In a very few cases, those adjudicated at the second and third levels, the effective date of the award may be later than the date of application. However, in any case where a delay beyond the control of the applicant has occurred, the act provides that an additional award in an amount equivalent to up to two years pension may be made to compensate for the delay.
