#### BIDS ON FRIGATE PROGRAM

Hon. Elmer M. MacKay (Central Nova): Madam Speaker, on June 13 the Minister of National Defence may have contradicted, by press release, his pledge of fairness in dealing made in committee. I should like to ask him whether he considers he has contradicted his pledge of fairness by arbitrarily excluding two of five consortia from making a second bid on the \$3.2 billion frigate program.

Can the minister clarify this situation, particularly in view of the almost defenceless position of our navy which was so graphically illustrated in the recent exercise in the Bay of Biscay, and the obvious need to strengthen our navy as soon as possible?

Hon. J. Gilles Lamontagne (Minister of National Defence): Apparently, Madam Speaker, today is my day. In reply to the hon. member, may I suggest that he direct his question to the Minister of Supply and Services whose officials are dealing with the main parties involved in the frigate program.

Mr. MacKay: Madam Speaker, I thank the minister for his answer and I will ask him this question; or perhaps the Minister of Supply and Services might care to answer it.

As I understand it, this vital program is approximately 18 months behind schedule. Since it appears that the government has broken its own rules as stated in the "Request for proposals" which indicated that proposals received after 1200 EST on November 30, 1978, would be rejected, is there any indication that legal action will be taken by those who have been discriminated against? Further, can the minister explain or justify this extra delay in a program which seems to have slipped another 18 months today?

Hon. J.-J. Blais (Minister of Supply and Services): Madam Speaker, I should like to say that there has been no discrimination. Both corporations had sent in tenders which have been turned down in the normal way, because their respective tenders did not meet the requirements of the call for tenders. We have asked the other three corporations who had submitted tenders to "correct", so to speak, their tenders to meet the Canadian content requirement in the three tenders and the Canadian capacity in a new technology, and I am sure the hon. member supports this policy put forward by this side of the House.

TERMS OF LOAN TO VALLEYFIELD CHEMICAL PRODUCTS CORPORATION—INVESTIGATION OF SPACE RESEARCH CORPORATION

Can the minister tell us, further, whether the loan is still outstanding and whether the grant has been terminated?
