The Scott Act

To the Editor of The Advertiser:

In your evening edition of yesterday you notice a conversation between two or your citizens as to the cause of the failure of the Scott act. Permit me to place before your readers a remark or two on that subject. The act was defective in the executive necessary to operate it, and also in that it did not prohibit the importation of liquor. In this province, just at the time when the act was being carried in the different counties, the Mc-Carthy act was passed, by which the Dominion Government assumed control of the liquor traffic; and as most of the inspectors and commissioners appointed under it were unfavorable to the Scott act very little effort was made to enforce its provisions. In this county there was none, at least, by the executive. At the end of the first two years, during which the legality of the McCarthy act was being test-ed in the courts, the Ontario Government again assumed control of the licensing system, and apparently made an honest effort to operate the Scott act; but the liquor men had been emboldened by the laxity of the two previous years, and it was found almost impossible to make the act at all effective. If the Scott act had been introduced under more favorable auspices there is little doubt that the results would have been much more satisfactory, as we have every reason to believe, in this county, at least, that the liquor men were in many cases inclined to abide by the decision of the people and respect the law. Judging from the outcry at present being made against the Scott act, though evidently when facts are con-sidered without justification, there is little doubt that should the vote on the 29th be adverse to prohibition the failure of the Scott act will be a chief factor in its defeat. FANNY DAVENPORT. Fanny Davenport, whose death at Melbourne Hall, Duxbury, Mass., was announced on Tuesday, had been pro-minent on the stage for many years, ranking in point of continuous service at the head of all the actresses of the United States. Edward Loomis Daven-

port, an actor almost great and altogether fascinating, and Fanny Eliza-beth Vining, an English actress, were her parents. But the histrionic strain did not begin with them. Mary Anne Davenport, a noted English actress of the last century, was an ancestor, and there were several stage favorites among the intervening generations. Miss Davenport was born in London, England, April 10, 1850. Her father was at one time manager of the Athenaeum in Boston, and Fanny was a mere child when she began her professional career there in "Metamora." At 14 she played in the "Black Crook," and prior to that she had won favorable notice at Niblo's in New York, where she appeared as the King of Spain in "Faint Heart Ne'er Won Fair Lady." A long period of stock and soubrette work followed, the dull grind that is necessary in any profession before crude material can be made available. It was this arduous training that fitted Miss Davenport for her first real trial, which was made in 1869, when Mr. Daly was impressed with her ability. As Lady Teazle, Rosalind, Nancy Sykes, and, above all, as Mabel Renfrew, in "Pique," Miss Davenport achieved success. There was no trouble about star-ring after that.

Miss Davenport was a dashing actress, who appreciated the full value of dress and personal embellishment. For ten years she toured the country, and in 1883 she commenced the "Sardou period" with "Fedora," and continued presenting the plays of that author until the end. Miss Davenport spent a fortune upon each of the plays, gave immense sums to the dramatist, and added to her own bank account enormously. No other American star has taken such risks or gained such rewards. She was a very rich woman and she worked for every cent she got. Miss Davenport was twice married, the first time to Edward F. Price, in 1879. She was divorced in 1888, and married her leading man, Melbourne McDowell, in 1889, and with him she had lived happily ever since. She was billed to appear here, at the Grand Opera House, some months ago, but was taken ill and never filled the engagement.

STORM-TOSSED

Terrible Experience of a Pacific

Liner.

The Columbia Nearly Blown Ashore on the Japanese Coast.

Tacoma, Wash., Sept. 28. - Fresh from an encounter with a terrific typhoon off the coast of China, the Northern Pacific steamer Columbia steamed into port last night. The vessel was tossed like a shingle 12 hours, driven many miles back on her course and carried so near the coast of Japan that the seas shipped by the vessel left deposits of sand on the decks. The anchor had been cast, but the chain snapped, and the anchor and the cable were lost and the ship was forced near the shore.

The storm occurred Aug. 29, off Foo Chow, China. The escape of the Columbia is considered miraculous and everyone aboard believed the ship would never live through the storm. The Chinese sailors practically mutinied after the vessel was near shore and would not be driven to work. The Europeans aboard, comprising

only the officers, were compelled to do the work, with no assistance but that of a few sailors who happened to be passengers on the ship. The freight brought by the Columbia amounts to 1.300 tons of tea, silk and general products. The bulk of the cargo is tea.

THE REMAINS OF COLUMBUS

To Be Removed From Cuba to

Spain.

Unaccomplished Plans to Honor the Noted Discoverer May Be Completed at Home.

Havana, Sept. 28 .- The remains of Christopher Columbus, which were removed from their niche in the cathedral on Monday preparatory to their shipment to Spain, had laid in their late resting place since Jan. 19, 1796, when they were brought from Santo Domingo, that island having been ceded to France by Spain.

Since the date mentioned the re-mains have laid in an open niche in the wall of the presbytery of the cathedral, a yard and a half above the ground, between a sillar supporting

the main arch and the choir. In 1892 there was placed in front of the niche a slab of doubtful artistic taste, representing a relief in bust of the great admiral and bearing this inscription in Spanish:

"May the remains and image of the great Columbus lie a thousand centuries preserved in this urn and in the remembrance of our nations."

After the four hundredth anniversary of the discovery of the new world by Columbus the Spanish Cortes included in the Cuban budget large sums for the purpose of erecting a monument symbolizing the travels of the discoverer to be placed in the most conspicuous place in Havana and the construction of a mausoleum to hold his ashes. This mausoleum, the work of the Spanish sculptor Melida, was brought to Havana and placed upon a base erected in the center wall of the

cathedral close to the main door. The monument, the work on which was intrusted to the sculptor, Sisillo, has not come and probably never will come to Havana. It was to have been paid for by an appropriation included in the budget of the island, but circumstances have overturned the plans made on the occasion of the celebration of the four hundredth anniversary of the discovery of America, and it is probable that both the monument and the mausoleum will be placed in a fitting place in Spain, where they will be looked upon as one of the treasures of the Spanish nation.

"TEDDY" GOT IT

Theodore Roosevelt Secures the Re publican Nomination for the New York Governorship.

Saratoga, N. Y., Sept. 28 .- The Republican convention nominated the following ticket resterday: For governor, Theodore Roosevelt, of Oyster Bay for lieutenant-governor, Timothy L. Woodruff, of King's; for comptroller, William J. Morgan, of Erie; for secretary of state, John T. McDonough, of Albany; for state treasurer, John B. Jaeckel, of Cayuga; for state engineer, Edward A. Bond, of Jefferson; for attorney-general, John C. Davis, of On-

The platform adopted indorses in strong terms the St. Louis platform, and condemns the free silver "heresy" of the Democratic party. It congratulates the country on the successful conclusion of the war with Spain and says that Porto Rico, Cuba and the Philippines should be retained as American possessions.

Although Governor Black was "turned down" with a terrible thump, by Senator Platt and his colleagues, yet the platform indorses Black's administration. Roosevelt was nominated on the first ballot, receiving 753 votes to 218 for Black.
