Instead of quarterly returns as to bonds,
debentures, etc., the proposal is now to
have them half yearly.
On April 1, of each year, a gain and loss exhibit must be filed with the insurance
department by each company showing the source of the increase and decrease in the company's surplus. Some exceptions are made as to British companies.
Annual inspection at head offices by the superintendent or his staff is provided for.
The clause regarding the limitation of expenses, and to which there was much objection, is struck out.
Advances for traveling expenses or against commissions are authorized in respect of first year premiums.
No salary or compensation is to be paid any director unless authorized by the shareholders, nor shall agents get more than \$5,000, save by a vote of the directors.
Sliding scale contracts with agents, based on volume of their business, are permitted.
From the clause respecting assets and investments in Canada by foreign companies, there is struck out the words, "At least two-thirds in market value of which shall consist of investments in or loans upon Canadian securities."
The clause respecting investments generally is not to be effective till Jan. I next.
