OSHAWA BOARD OF TRADE:—Petition for an Act of incorporation, 141. Report of Notice, 146. Bill presented; Referred, 182. Reported, 309. Considered in committee; Reported; Passed, 318. By the Senate, 418. R. A., 435. (36 Vic., c. 68.)

OTTAWA, RIVER:

1. Petition for a survey of the channels South of Allumette Island, before any further expenditure is incurred on the Culbute Channel, 120, 174, 180, 429.

2. A petition praying that the contemplated improvements at the Culbute Rapids may be carried out, and an additional sum granted,—rejected (not recommended), 174.

PACIFIC RAILWAY:

1. A Member (Hon. L. S. Huntington) having stated that he was credibly informed that an agreement had been made between Sir Hugh Allan (for Canadian capitalists) and the agent of certain American capitalists, whereby the latter were to furnish the funds for the construction of the Railway, and to give the former a per centage of interest;—and that subsequently an understanding was come to with the Government by which Sir Hugh and his friends advanced a sum of money to aid the election of Ministers and their supporters, at the ensuing General Election, receiving in return, the contract for the construction of the Railway;—he moved the appointment of a Select Committee to enquire into the circumstances connected with the Railway negotiations, and with the granting of the Charter to Sir Hugh Allan and others; Negatived, on a division, 115.

2. Select Committee appointed to inquire into and report on the matters contained in the foregoing paragraph (on motion of Sir J. A. Macdonald); To report from time to time; To report the evidence from time to time; Leave to sit after the prorogation, 137. Instruction to examine witnesses on oath, 267. Motion that the Committee have leave to sit although the House be not sitting at the time; Amendment, that as the Committee has no power to enforce the attendance of witnesses, it is essential that the House should sit on the day to which the Committee has leave to adjourn, negatived; Main motion agreed to, 308. All questions to be decided by a majority of voices, including that of the Chairman, who shall not have a casting vote, 430. **FIRST REPORT**, recommending that they be empowered to examine witnesses upon oath, 166. (See *Witnesses*, 2.) **SECOND REPORT**, desiring leave for certain Senators to attend; Message sent to the Senate, 212. Granted, 229. **THIRD REPORT**, with Resolutions for empowering them to adjourn till July,—to sit at such place as may be found expedient,—and that the proceedings should be secret, 275. Motion that they have leave to adjourn till 2nd July, and to adjourn from place to place; Amendment, that nothing has occurred to justify the proposed adjournment, &c., Negatived; Main motion agreed to, 287. **FOURTH REPORT** (adjournment to Montreal, &c.), 294: Concurred in, 370.
