Kootenays urging deferment of final consideration of any treaty with respect to development of the Columbia until these organizations have had an opportunity to present a brief to him in person in support of their contention that some aspects of the proposed treaty will have serious and prejudicial effects upon the economy of Canada and British Columbia, and will destroy vital Canadian and British Columbia equities? Is the Prime Minister prepared to accede to this request on the part of a large group of organizations and other people in the Kootenays?

Right Hon. J. G. Diefenbaker (Prime Minister): Mr. Speaker, I will have to check in my office for the purpose of ascertaining what representations, if any, have been made. Having done that, I will give an answer to the hon, member.
