MOTION FOR CONCURRENCE IN FOURTH REPORT OF SPECIAL COMMITTEE

Mr. D. Gordon Blair (Grenville-Carleton) moved:

That the fourth report of the special committee on procedure of the house, presented to the house on Friday, December 6, 1968, be concurred in.

He said: Mr. Speaker, I rise to move concurrence in the fourth report of the special committee on procedure of the house. In doing so, I hope—

Some hon. Members: Oh, oh.

Mr. Blair: I must say immediately that we did not take into consideration the electronic devices, but perhaps we should have.

Mr. Nowlan: The lights of parliament are getting dim.

Mr. Blair: In undertaking this task I hope that without offending the rules of the house I can explain briefly the nature of the three reports which were filed on Friday last. The third report is an explanation of the various recommendations made by the committee. These recommendations are set forth in the form of draft standing orders in the fourth and fifth reports. The fourth report contains major recommendations of the committee dealing with such matters as supply, ways and means, the legislative process, the programming of business, and so on. The fifth report contains a number of important but less significant amendments and also includes a number of amendments which would be consequential upon the adoption of the fourth report.

In making these remarks I am conscious of my duty as chairman of this committee. I intend to speak factually, objectively and dispassionately in an attempt to explain what this committee, composed of representatives of all parties in the house, attempted to accomplish in its reports.

I should say at once that your committee held 26 meetings in the space of almost three months and that all of its deliberations were marked by extreme cordiality and by the fullest and frankest exchanges of opinion.
