CREAM-REPORTED DELAY IN SUBSIDY PAYMENTS

Mr. H. A. Olson (Medicine Hat): I should like to address a question to the Minister of Agriculture. On October 7 I asked if he would undertake to make a statement in this house with regard to what appeared to be an undue delay in the issuing of the cream subsidy cheques. At that time he replied there was a possibility his estimates would be called later that day and he would be prepared to make a full statement with regard to this matter at that time.

Well, Mr. Speaker, as you know his estimates were not called that day and they have not been called since. I wonder if the minister would give us now a reasonably full statement respecting this delay, so the letters members are getting can be answered and so the cream shippers will understand why these cheques are not getting to them as quickly as they think they should.

Hon. J. J. Greene (Minister of Agriculture): As the hon. member knows, Mr. Speaker, the cream subsidy cheques only go out every three months; therefore to date there has been only one payment. The second payment to the cream shippers would be going out in November. There has been some delay in the province of Alberta by reason of the fact that returns from some plants came in late. As a matter of fact some have only made their first returns recently, and some of those returns were inadequate. This situation is being cleared up between the plants and the officials of the stabilization board at the present time. If the hon. member wants a specific report about Alberta, I will be pleased to send it to him in writing.
