MANITOBA INTERLAKE FRED AGREEMENT

Question No. 2,406-Mr. MacDonald (Egmont):

1 Is a federal-provincial working group presently reviewing and revising the Interlake FRED Agreement for Manitoba?

2. What are the terms of reference for this activity?

3. Who are presently members of that group?

4. What is it considered will be the essential changes made in the present Interlake Agreement?

5. What representations have been received from the Interlake area and what attempt is being made to consult the various area and regional boards with regard to these revisions?

Mr. Russell C. Honey (Parliamentary Secretary to the Minister of Regional Economic Expansion): 1. Yes, in accordance with the terms of the agreement.

2. To examine what program changes, if any, would assist in achieving the objectives of the plan.

3. Staff of federal and provincial departments, under the joint co-ordination of the federal and provincial managers of the plan.

4. The guidelines for the review are based on the view of the two governments that the Agreement is generally working satisfactorily. Consequently they envisage no fundamental change of the plan, and no important modification of the Agreement's present overall financial structure. They do, however, call for improved co-ordination by bringing more existing federal programs within the plan, thereby broadening its capacity to meet the problems of low income and low participating people.

5. The local chairmen of the ten Area Development Boards have presented their views to the Manitoba Minister and to the Interlake Advisory Committee. Representareview working groups. Draft findings incorporating these views have been discussed with the boards. There have been consultations with the chiefs and councils of Indian bands in the Interlake area.
