- 2. The total length of the Alaska Highway from Dawson Creek to the Yukon-Alaska boundary is 1,221 miles. (a) 102 miles. (b) Mile 0 (Dawson Creek) to Mile 84, Mile 300 to Mile 301 (Fort Nelson) and Mile 904 to Mile 921 (vicinity of Whitehorse). (c) Mile 921 to Mile 928 is presently under paving contract and will be completed this year.
- 3. Reconnaissance surveys for relocation have been carried out for Miles 206 to 278 and Miles 315 to 496. Detailed surveys have been completed only on Miles 206 to Mile 232. No reconstruction program planned for 1971-72.
- 4. No discussions have been held with other jurisdictions for cost-sharing of paving of the Alaska Highway. The recent U.S. Federal Highway Act authorized the President of the U.S.A., acting through the Secretaries of State and Transportation to undertake negotiations with the Government of Canada.
