NATO. In 1970-71 Canada was one of the contenders to provide such a craft based on the *HMCS Bras d'Or* design but the U.S. craft was chosen because of its lower cost. While considering the gun/missile boat program NATO nations also looked into the use of hydrofoils as anti-submarine craft. *HMCS Bras d'Or* was offered as a test platform for a NATO project group. While some six nations expressed interest none have agreed to supply the funds required for such a program.

## GROS MORNE NATIONAL PARK

Mr. Cossitt: Mr. Speaker, I rise on a point of order. I respectfully refer the parliamentary secretary to order paper questions Nos. 2,271 to 2,280 inclusive which ask for the names of lawyers on the list maintained by the government of those selected and approved to do government legal work. I first asked for this information by order paper questions about five months ago in early April, and when the requested information was not forthcoming in the answers I again sought the information by means of the order paper questions to which I draw attention today because they have remained on the order paper unanswered for almost three months.

This is the third or fourth time I have risen on a similar point of order and asked for some indication from the parliamentary secretary of when answers will be forthcoming. I have been given no valid reason so far why this information has not been furnished. I conclude by saying that surely the parliamentary secretary must be by now in a position to indicate to the House when these answers will be given. Anything else can only indicate questionable skeletons in the government's pork barrel legal closet.

Mr. Clark (Rocky Mountain): On a point of order, Mr. Speaker, I should like to draw the attention of the parliamentary secretary to starred question No. 2,346 which has been on the order paper in my name since June 21, 2½ months ago. It asks for the names and lines of responsibility of any staff that might be accountable to the Minister of State in charge of multiculturalism, if indeed he has any staff.
