NATIONAL REVENUE

REGULATIONS PERTAINING TO CHARITABLE ORGANIZATIONS— MOTION UNDER S.O. 43

Mr. Andy Hogan (Cape Breton-East Richmond): Mr. Speaker, under the provisions of Standing Order 43, on a matter of urgent and pressing necessity I raise the following matter based on information circular 78.3 of the Department of National Revenue. According to the circular, its purpose as noted in paragraph 1 is to explain to registered charities and to charities seeking registration the consequences of carrying on activities that are political in nature. On page 3, point 2, under the title—
