REGIONAL ECONOMIC EXPANSION

AID FOR MICHELIN TIRE—DISCUSSIONS WITH PREMIER OF NOVA SCOTIA

Mr. J. P. Nowlan (Annapolis Valley-Hants): Madam Speaker, in view of the fact that the hon. member for Hamilton Mountain has, unfortunately, confused the problems of the car industry with problems of development in other parts of Canada, I wish to put a question to the Minister of Regional Economic Expansion.

As this question involves joint expenditures of the federal and provincial governments, however, I know that the Minister of Finance is fully aware of the problem. Could he assure this House that the Michelin application under DREE, a national policy of both governments, will be considered on its merits, and will not become involved in any other confusion and/or problems of other industries in other parts of the country? Has he recently had discussions with the Premier of Nova Scotia, and when can we except an announcement?

Hon. Allan J. MacEachen (Deputy Prime Minister and Minister of Finance): Madam Speaker, I had discussions with Premier Buchanan last weekend by telephone and the earlier weekend, in person—at his request—on a number of development matters affecting Nova Scotia. One of the items we talked about was Michelin.

FINANCIAL ASSISTANCE—LIST OF COMMITMENTS OF GOVERNMENT

Would the Secretary of State place upon the table of the House of Commons a list of all the commitments by the Government of Canada to the advancement of culture and arts in the country which he is contemplating breaking?

Hon. Francis Fox (Secretary of State and Minister of Communications): Madam Speaker, I would be delighted to

table with the House a list of all the campaign promises made by my predecessor during the course of the election campaign. I would be delighted to do that, indeed. I would also be interested in seeing whether they were commitments made by the previous government, whether these campaign promises have gone through the process of Treasury Board and cabinet approval, and whether they were indeed campaign promises, as I believe they are.
