**ROUGE VALLEY PARK**

**Mr. Bill Attewell (Markham—Whitchurch—Stouffville):** Mr. Speaker, my question is for the Minister of State for the Environment.

It has been over two years since this government promised \$10 million to help in the establishment of an urban park in the Rouge Valley which is on the east of metro.

I would like to ask the minister: Why the delay? Why the hold-up? Who is dragging their feet? This is a very important project on a national basis. I would like the minister's comments. Can we get this solved?

**Hon. Pauline Browes (Minister of State (Environment)):** Mr. Speaker, the interest, the commitment and the work by the hon. member and other members in the House are really to be commended on this magnificent Rouge area to be saved as a park.

The advisory committee that was established and constituted by the province of Ontario—and the federal government is a member—has put forth a management plan. The first report I have in hand here today. This is a comprehensive and an envisionsary document. The first public meeting on this is scheduled for tonight.

I would like to say the final report is expected in the spring of 1992. The Federal Historic Sites and Monuments Board is also looking at the archaeological aspects of the Rouge, and indeed the \$10 million federal commitment stands ready to be set forth as soon as this park is established as the largest urban park in North America.
