## MILLIONS ARE AT STAKE.

## THE WARD WILL CONTEST AGAIN TO THE FRONT.

Up Before the Chancery Court in Detroit—  
Relatives of the Late Millionaire Will  
Not Let the Case Remain Quiet—A  
Well-Known Toronto Lady Subjected  
to Much Litigation.

Detroit, April 16.—Judge Carpenter, sitting in Chancery has heard pleadings in the celebrated Ward will case, with so much of the testimony as has been taken outside of the court.

The Ward property was managed by the executors and transferred to Mrs. Ward-Cameron and her brother, Mrs. Ward called to her aid her two brothers, John B. Ward and James Ward, one of the most prominent operators in wheat, corn and stocks on the Chicago Board of Trade, and Thomas E. Lyon, a Chicago millionaire lumberman, and head of the great investment banking company of Lyon, Garity, & Co., of Chicago. The estate of Mrs. Lyon was so large that the estate if realized upon at once would scarcely more than pay its debts, and that the only way to protect their sister's interests was to acquire all the debts and trust to a revival of business to approach the properties in value. They induced the executors to sell the property, and this work was continued for over two years.

In this way the estate was liquidated and the bequests of the will wiped out. It is claimed that none of the heirs, including Mrs. Ward, received a single cent under its provisions. Charles H. Ward, only son of Mrs. Ward-Cameron, has received some \$40,000. Henry Ward was supported until he died. Elizabeth Ward in support of the estate for the same at \$10,000. Aunt Emily received a sum of money, said to be \$25,000. The eight nephews and nieces received \$100,000 between them as a present. Mrs. Mabel Seitz of Detroit, a granddaughter, received \$100,000. Up to 1888 Mrs. Ward-Cameron gave away about \$100,000.

It is claimed by the contestants that the executors, however, were partly at their expense, and was irregular and illegal. The main points of their contention is that while it was the period of stagnation after 1878, they were entitled to a share of the profits, when received by Mrs. Ward-Cameron and her brothers.

For the past two years testimony in the case has been taken in various cities and now both sides are all but ready to have judgment passed upon the case.

THE HISTORICAL EXHIBITION.  
Addresses Presented to the Earl and Countess of Aberdeen.

The society for promoting the Canadian Historical Exhibition, which was organized last year, met yesterday afternoon in the Canadian Institute. Among those present were Mr. J. A. MacCallum, M.L.A., Chancellor Burwash, W. Kennedy, Prof. Clark, Rev. Father Ryan, David Ross, Mr. MacCallum, A. D. Preston, Scott and Graham, J. C. Copp, A. MacMurchy, Rev. E. A. Welch, Secretary of Trinity, J. Bain, Jr., Dr. Bright.

The Earl of Aberdeen presided. He was presented with an address in which His Excellency was thanked for accepting the office of hon. president. The address proceeded to quote a letter from Gen. Baillie-Laird, of the United States, that should the Canadian Historical Exhibition Association obtain pecuniary assistance from the Dominion Government, the Government of the United States would also probably assist.

The address was read by Secretary Boyd, and signed by O. A. Howland, president, the secretary and assistant secretaries.

In reply, His Excellency said he hoped that the Dominion and Provincial Governments would extend their assistance, that the exhibition would be made thoroughly Canadian, and that the early French explorers would not be forgotten.

An address from the society was also read to Lady Aberdeen, thanking her for the interest she had taken in the work.

Short addresses were delivered by Prof. Clark, Hon. Mr. MacCallum, Mr. Ryan and Prof. MacCallum.

Rev. Provost Welch moved a vote of thanks to the Governor-General and Lieutenant-Governor for their attendance, which was carried with loud applause.

Conventions for the selection of the Conservative party candidates will probably be held within the next two or three weeks. The calling of the conventions rests with the Central Conservative Association. The delegates will be three from every polling district (or division of a subdivided district) and one delegate from each of the Young Men's Liberal-Conservative Association.

The conventions for West, East and North have been held, but the nominations for none of the Toronto districts have yet been made. At the annual election West Toronto will elect two members, each voter being entitled (as in Hamilton) to cast two votes. This is a new provision, a second member being given to West Toronto in consequence of the growth of the constituency.
