Hazleton, Pa., Oct. 15.-Three men were fatally and a score of others more or less seriously injured last night in a trolley accident at the Hazleton crossing of the Delaware, Susquehanna and Schuylkill Railroad and the Lehigh traction line. The dead are: Jefferson Kirschner, of Hazleton, a telegraph operator; Wm. Stapleton, of Milton, a telegraph operator; David John Williams, of Ply-mouth. Patrick Dowd, a trolley conductor, and Morris Ferry, a boy, are at the hospital unconscious, and are not expected to live. The engine caught the rear end of the car and tore it from the main portion, which was thrown over an embankment into a swamp. Kirschner, who was near the rear end of the car, was caught and dragged over 100 yards before the engine could be stopped.

Ought Milk to be Peddled on

Ministers Think Sunday Delivery Ex-Entire Prohibition - An Interesting

Whether milk shall be delivered or not on the Sabbath is a question which directly concerns nearly every household in the city,

The milkmen maturally object to Sunday delivery, as it entails a day's extra work, without corresponding profits, because if people could not get milk on Sunday, many of them would purchase a double supply on Saturday. The Dairymen's Association, to which nearly all the milkmen belong, will, therefore, petition the City Council to

prohibit Sunday milk peddling. There are two sides to the question, however. A number of citizens have been spoken to, and their opinions are summarized in the following brief in-

Mr. John Friend, the confectioner, was decidedly opposed to Sunday milk selling and all unnecessary Sunday work. He had never found it necessary, either in his family or his business, to have milk served on a Sunday. He would not ask another to do for him what he thought was wrong to do himself. The milkman's horse, as well as the driver, needed the Sab-

Mr. James Wilkins, barber, would like to see Sunday milk peddling pro-hibited. The rattle of the milkman's wagon and bell-often heard while divine service was going on—disturbed the quiet of the Sabbath. The work

was not necessary.

Mr. John Chamberlain, barber, was opposed to Sunday milk selling. He did not want milk brought to his place on the Sabbath. He did not want to work on Sundays, and would not ask another man to do so. Mr. Norman McLeod, grocer, was

opposed to unnecessary Sunday work. There was no need to peddle milk in the winter on the Sabbath; but he hardly saw how it could be avoided in the warm weather, especially where there were young children in the and could not well afford to buy ice.

Mr. James A. Dobie, barber, didn't believe in Sunday milk selling, and took care to engage a milkman who did not peddle on the Sabbath.

It cannot be fresh and pure if standing over in an ordinary cellar from Saturday morning until Monday morning. Milk delivery is one of the necessities of

Dr. Cl. T. Campbell, chairman of the Board of Health, said: "I am personally in favor of a Sunday delivery. In families where there are infants or invalids, fresh milk is a very necessary article, and any hard or fast law might be a hindrance. But people generally should do as little dealing on Sunday as possible, and not caus others to do more than necessary.

He believed in no Sunday labor, except when it was absolutely necessary. Rev. M. P. Talling's views agreed with Mr. Stuart's. There were some classes of labor necessary on the Sabbath. Sunday milk peddling in cool weather did not come under that heading, but in warm weather it was ex-

"I would rather have my milk delivered on Sunday before church than have to drink sour milk," said Mr. C. F. Colwell. "Let those who are suggesting these wonderful reforms pro-vide an adequate remedy. Very few of them could keep it with advantage. That is not the only thing. Many of the dealers, I feel sure, would be unable to supply the demand on Monday. day morning, because people don't want old, nor yet skimmed, milk, About half the infants in the city are fed on cow's milk, and this wil have to be procured fresh daily. It is an absolute necessity to have Sun-day milk peddling, in the summer

months especially.

wages on holidays unless he works. Prospect Hill.-Can a person lawfully take a neighbor's animal that is on the road, put it into his stable, keep it over night, and then notify owner to take it away? If not, is the person liable to an action in law? Ans.-An animal distrained for unlawfully running at large should be delivered to the pound-keeper. It is only when such animal is trespassing on private property that the owner of such property may lawfully retain the animal in his own possession, and provided he makes no claim for damages. A person distraining and retaining in his possession an animal running at large and not trespassing is liable to an action, but unless substantial damages could be proved, only nominal damages would be recovered, and the judge or court would probably not allow costs.

Ontario.-We have been troubled considerably by a bad neighbor doing injurious things on the sly to me and others. Among other things he mer at night and take them down to tant, where I could not find them, and cut their tails off; and on his arrival back home he was to pull his boots off outside and slip upstairs quietly to bed, for which he offered him \$5 reward, which the young man refused, stating that he had nothing against me that he should do such a dirty trick.
