

SAYS 'SHOOK DOWN' AMBITIOUS COPS

Witness Gave Former Saloonkeeper \$26,300 to 'Fix' Promotions.

New York, Feb. 14.—Policeman Patrick J. Twomey, who was suspended last March in connection with alleged promotion graft, was a witness in General Sessions at the trial of Michael J. Burke, a former Harlem saloonkeeper, who is charged with taking \$26,300 from eighteen policemen un-

der the pretence of obtaining for them promotion to the rank of sergeant through fraudulent Civil Service examinations. Twomey was the principal witness at an investigation of the charges against Burke in 1922 by Commissioner of Accounts Hirschfeld. At that time he was alleged to have admitted that he accepted \$1,600 from the policemen and turned \$26,300 over to Burke, who formerly was a policeman. Burke was alleged to have pretended that he had influence with employees in the Civil Service Commission who could "doctor" the examination papers so that the names of the eighteen would be placed at the top of the eligible list. However, when Twomey was called to the witness stand by Assistant District Attorney Carstarphen, he asserted that his memory had failed him on many important incidents, although he had testified before Commissioner Hirschfeld and later before

the Grand Jury to collecting the money and giving it to Burke. Reminded by Judge Nott that he was under oath, Twomey said: "When I testified before Hirschfeld I was a sick man. I hadn't slept for weeks. I was on the verge of a nervous breakdown and later on I was told by a clergyman to get the matter off my mind or I'd go to an insane asylum." It was not until Judge Nott told him that he would go to the Tombs on a perjury charge if he wasn't frank in his testimony that Twomey admitted he was introduced to Burke in August, 1921, a few days before the Civil Service examinations were to take place, and that he gave Burke the \$26,300, which he had received from the policemen. He said that the month following the examinations, and after Burke had sailed for Ireland, he heard that the names of the eighteen policemen had not been placed at the top of the eligible list and inquired at the office of the Civil

Service Commission why the policemen had not been permitted to pass the examination. Twomey also admitted that it was this inquiry which led to the investigation and that he had given to one of Hirschfeld's men a paper containing the names of the eighteen policemen and the amount of money he had received from each.
