

Amendments to Constitution and Canons recommended by Committee on Revision and Consolidation of the Canons, and adopted and passed June 23, 1892. (See Page 49).

Constitution, Section 3, line 6.—To strike out the word "united."

Section 3, line 7.—To strike out the words "and Ireland."

Section 12, line 3.—To substitute the word "shall" for "will."

Section 15, line 3.—To substitute the word "executive" for "standing."

Section 19, line 5.—To strike out all the words after the word "time" and add the following: "and when the See becomes vacant by the death of the Bishop, or in case of the incapacity of the Bishop, the Honorary Secretaries of the Synod shall summon a meeting of the Executive Committee *which* shall elect a chairman of the committee *who* shall administer the Diocese so far as the financial business is concerned, and sign all cheques until the consecration of a Bishop."

Section 20, line 7.—To substitute the words "the proceeds" for "that."

Section 20, line 9.—To substitute the word "shall" for "to."

Section 20, line 9.—To insert the words "within—days after being made" after "Synod."

Section 21, line 2.—To strike out the words "or during the vacancy of the See."

Section 21, line 3.—To insert the words "or during the vacancy of the See by—" after "Diocese," and add the words "an assistant" at the end of the section.

Section 23, line 7.—To substitute for "and shall vote whether there be an equality of votes or not" the words "and be entitled to vote."

Section 26, line 4.—To strike out the words "united" and "and Ireland."

RULES OF THE EXECUTIVE COMMITTEE.

Section 2, line 1.—To substitute the word "before" for the word "by" at the end of the line.

Section 2, line 2.—To strike out the words "from the time that they are promised"

Canon II., lines 4 and 5.—To strike out the words "previous to his consecration" out of line 5 and insert them in line 4 after "shall."

Canon XI., Section 1, line 8.—To insert the word "and" after "voters."

Canon XI., Section 1, line 9.—To substitute the word "shall" for "to."

Canon XI., Section 3.—To strike out the word "and" at beginning of section.

Canon XIV.—To strike out the recital, Sections 1 and 6, and the word "that" at beginning of Sections 2, 3, 4 and 5, and to renumber Sections 2, 3, 4 and 5 as Sections 1, 2, 3 and 4, respectively.

The Canon as at present (passed in 1885) reads as follows:—

XIV.—TO PROVIDE FOR THE RE-ARRANGEMENT OF THE PARISHES AND MISSIONS OF THE DIOCESE.

"Whereas it has been found necessary in order to provide from time to time for the better application of the Mission Fund, and wherever practicable to relieve the Missionaries of the Diocese from unnecessary labor, it is hereby enacted:—

1. That Canon XIV. is hereby repealed, and the following constituted therefor:

2. That the Executive Committee is hereby empowered from time to time to rearrange the Parishes and Missions of this Diocese, subject in all cases to the Bishop's approval of any rearrangement.

3. That such re-arrangement shall be made after due enquiry by a Commissioner or Commissioners to be appointed by the Bishop, into the case of any Parishes or Missions that will be affected by any proposed changes.
