Sugar Down to 89 Points, a Net Loss of Two and a Half.

Montreal, Oct. 22.—As yesterday, net losses predominated in the close of trading today on the local stock exchange. Bromption again led the list, and the papers generally were active. Among the stronger issues were Wayagmack, with a net rise of five points to 165, and Rordon, up 4 at 212. Bromption was again somewhat erratic and apparently influenced by the directors' declaration of an increased dividend. It opened strong, touching 77, then sold off to 74, where support coming in, a rally to the close of 75 1/2 followed, a net gain of a fraction.
