the Bill to incorporate the Bolton Brook Navigation Company, and that the said Bill be read a second time.

The said Bill was read a second time.

ORDERED, That the said Bill be referred to the Select Committee appointed to examine and report upon Bills relating to Corporations.

The Honorable Mr. Botsford from the Committee appointed to wait upon His Excellency the Lieutenant Governor with the Address of this House respecting His Excellency's Despatches to the Colonial Secretary on the subject of the re-construction and improvement of this House, reported, that they had attended to that duty, and that His Excellency was pleased to say, he would reply to their Address by Message.

A Petition from the Mayor, Aldermen and Commonalty of the City of Saint John, praying re-payment of certain sums of money expended upon the Great Road near Saint John, leading to the Parish of Lancaster.
