Ordered, That the Bill be read the third time, at the next sitting of this House.

The House, according to Order, resolved itself into a Committee on the Bill to amend an Act respecting the Volunteer Militia Force; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. Jones (South Leeds) reported, That the Committee had made some progress, and directed him to move for leave to sit again.

Ordered, That the Committee have leave to sit again, at the next sitting of this

House.

And it being Six of the Clock in the afternoon, the House was adjourned by Mr. Speaker until Half-past seven o'clock this day, without a Question being first put.

Bill, intituled, "An Act to incorporate the Waterloo, Magog and Stanstead Railway

"Company."

And also, the Legislative Council have passed the Bill, intituled, "An Act to auth-"orize William John Bickell to construct a Bridge over the River St. Charles," with several amendments, to which they desire the concurrence of this House.
